**Last Day to Register to Vote:** Thursday, April 3, 2025

**QUALIFIED VOTER. (a) ... "qualified voter" means a person who:**

- (1) is 18 years of age or older;**
- (2) is a United States citizen;**
- (3) has not been determined by a final judgment of a court exercising probate jurisdiction to be:**
  - (A) totally mentally incapacitated; or**
  - (B) partially mentally incapacitated without the right to vote;**
- (4) has not been finally convicted of a felony or, if so convicted, has:**
  - (A) fully discharged the person's sentence, including any term of incarceration, parole, or supervision, or completed a period of probation ordered by any court; or**
  - (B) been pardoned or otherwise released from the resulting disability to vote;**
- (5) is a resident of this state; and**
- (6) is a registered voter.**

**Last Day of Early Voting: Tuesday, April 29, 2025**

**Candidate Eligibility Requirements:**

**Mayor**

- **Must be a United States citizen;**
- **Residence -- 1 year in state prior to the filing deadline; 1 year in city prior to election day**
- **Age – 18**
- **Must be a registered voter in territory elected from by the filing deadline\***

**Council Member**

- **Must be a United States citizen;**
- **Residence -- 1 year in state prior to filing deadline; 6 months in the city (or ward) prior to filing deadline (Texas Elec. Code, Section 141.001(a); Brown v. Patterson, 609 SW 2nd 287)**
- **Age – 18**
- **Must be a registered voter in territory elected from by the filing deadline\***
